### ARTICLES OF ORGANIZATION OF PLUTUS FUND MANAGER, LLC

The undersigned, acting as the authorized representative of Plutus Fund Manager, LLC (the "Company"), does hereby certify that said member has formed the Company to be a limited liability company under the laws of the State of Florida and under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, as amended (the "Act"), and, pursuant to the Act, hereby sets forth the following Articles of Organization:

#### **ARTICLE I: NAME**
