**ARTICLES OF ORGANIZATION
OF

The undersigned, Charles F. James, competent to contract and an authorized representative of RAUSCH COLEMAN HOMES NW FLORIDA, LLC, hereby presents these Articles of Organization as the Articles of Organization of RAUSCH COLEMAN HOMES NW FLORIDA, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is RAUSCH COLEMAN HOMES NW FLORIDA, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

ARTICLE III - PURPOSE AND POWERS


