**ARTICLES OF ORGANIZATION
OF
BLUE SKIES WPB LLC**

THE UNDERSIGNED certifies that the member has formed this limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

ARTICLE I – NAME
