# ARTICLES OF ORGANIZATION OF SNOW TOP LLC

The undersigned, CATHERINE WILKINSON SNOWDEN, a natural person competent to contract and an authorized representative of SNOW TOP LLC, hereby presents these Articles of Organization as the Articles of Organization of SNOW TOP LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

#### ARTICLE I - NAME

The name of the limited liability company is SNOW TOP LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

#### ARTICLE II - PRINCIPAL OFFICE ADDRESS

#### ARTICLE III - PURPOSE AND POWERS
