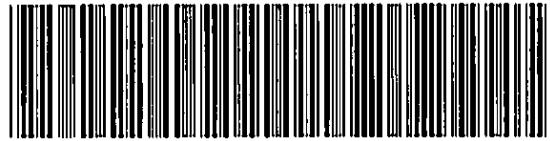

Article 4, of the Articles of Organization of the Company is hereby deleted in its entirety and replaced with the following:

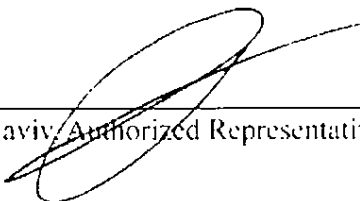
