The undersigned does hereby execute these Articles of Organization for the purpose of forming a professional limited liability company under the laws of the State of Florida.

**ARTICLE I
NAME**

The name of the professional limited liability company shall be:

**ARTICLE II
PERIOD OF DURATION**

The period of duration of the professional limited liability company shall be perpetual.

**ARTICLE III
PURPOSES AND DURATION**

ARTICLE V
REGISTERED OFFICE AND REGISTERED AGENT

The street address of the professional limited liability company's initial registered office in Florida is 2907 Bay to Bay Boulevard, Suite 201, Tampa, FL 33629, and the name of its initial registered agent is Jessica A. 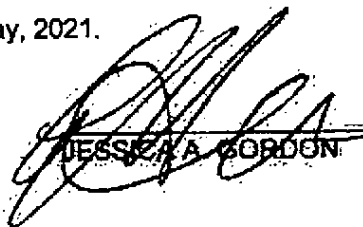
