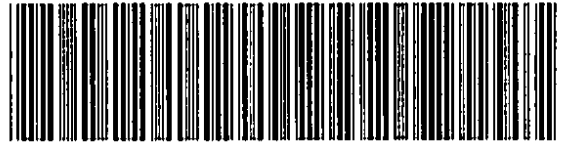



**ARTICLE I
