DURATION

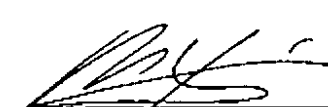
ARTICLE VII

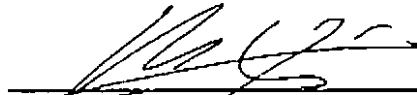
