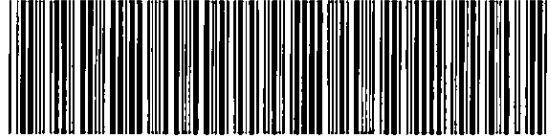

Management**




