**ARTICLES OF ORGANIZATION
OF TALLAHASSEE MERGER SUB, LLC**

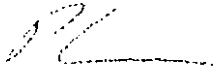
ARTICLE III. PURPOSE: The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.
