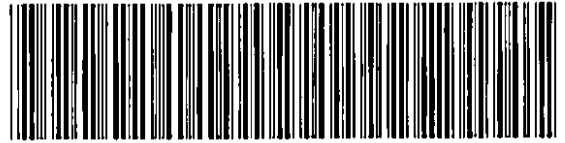

### ARTICLES OF DOMESTICATION


