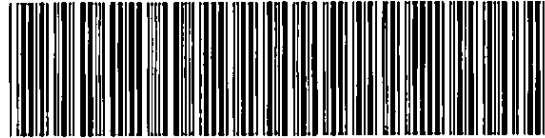

ARTICLE IV - Purpose


The purpose of this limited liability company is to invest and reinvest its capital for security, growth, income and any other investment and business purposes.
