**ARTICLES OF ORGANIZATION
OF

The undersigned, Margaret Matthews, a natural person competent to contract and an authorized representative of Matthews Bridal Company, LLC, hereby presents these Articles of Organization as the Articles of Organization of Matthews Bridal Company, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is Matthews Bridal Company, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

ARTICLE II – PRINCIPAL OFFICE ADDRESS
