**ARTICLES OF ORGANIZATION  
OF

The undersigned authorized representative hereby executes these Articles of Organization (“Articles”) for the purpose of forming a limited liability company (the “Limited Liability Company”) in accordance with the laws of the State of Florida.

**ARTICLE I.  
NAME**

**ARTICLE II.  
DURATION; EFFECTIVE DATE**
