**MANAGEMENT**

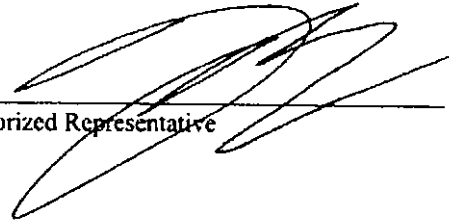
