**ARTICLES OF ORGANIZATION
FOR FLORIDA LIMITED LIABILITY COMPANY**

The undersigned member hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the state of Florida.

ARTICLE I

Name

The name of the Limited Liability Company is **LEOS FAMILY CUISINE, LLC** ("Company") and it shall be formed as a Florida limited liability company under Chapter 605, Florida Statutes.

ARTICLE II


