ARTICLES OF ORGANIZATION
of
SODA SPRINGS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Soda Springs, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 3948 3rd Street South, #206, Jacksonville Beach, Florida 32250.

ARTICLE II

PURPOSES AND POWERS

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. ARTICLE III


ARTICLE VII**DURATION AND COMMENCEMENT**


