ARTICLES OF ORGANIZATION
of
SEAHORSE REAL ESTATE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Seahorse Real Estate, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 2305 Greenside Court, Ponte Vedra Beach, Florida 32082.

ARTICLE II

PURPOSES AND POWERS

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. 


