

ARTICLES OF ORGANIZATION OF DA COSTA BRAZILIAN JIU JITSU - A WERDUM TRAINING CENTER LLC

Pursuant to the provisions of Chapter 605 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, the following are the Articles of Organization for Da Costa Brazilian Jiu Jitsu - A Werdum Training Center LLC (the "Company"):
