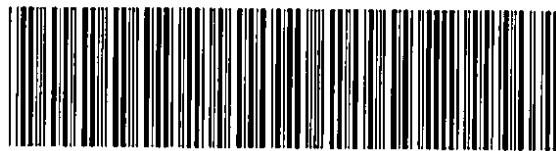

ARTICLES OF ORGANIZATION
OF
SUPPORT OPERATIONS SERVICES, LLC**

Pursuant to the provisions of Section 605.0202, Florida Statutes, **SUPPORT OPERATIONS SERVICES, LLC**, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to the Articles of Organization of the Company:

FIRST: The Articles of Organization of the Company were filed on June 7, 2021 and assigned document number L21000263773.

SECOND: Article IV of the Company's Articles of Organization is hereby amended and restated in its entirety to read as follows:

"ARTICLE IV


The Company shall be conducted, carried on, and managed by its member and is, therefore, a member-managed limited liability company."

THIRD: Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.

FOURTH: The effective date shall be the date these Articles of Amendment to the Articles of Organization are approved by the Florida Secretary of State.
