**ARTICLES OF ORGANIZATION

Cowie, a natural person competent to contract and an authorized representative of a member of Southern Self Storage of Santa Rosa Beach, LLC, hereby presents these Articles of Organization as the Articles of Organization of Southern Self Storage of Santa Rosa Beach, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Southern Self Storage of Santa Rosa Beach, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS
