We found out about this when we received unsolicited mail asking us to order 2021 Labor Poster Updates for his LLC. My wife, Naime Morgan is currently residing at this address as I am working overseas for the Department of Defense.

We notified Mr. Isik via phone call on multiple occasions in June and July 2021 to remove our address from this filing. He stated he didn't have an address and would remove ours in 1 week. Several weeks later in early July 2021, he stated to my wife he did so. When I performed a search of state records on the Division of Corporations website on 20 Aug 2021, I found this to be untrue. I am now reaching out to you to remove our address from these records. I have enclosed a copy of the Santa Rosa County Property Appraiser's website info (<https://www.srcpa.org/Parcel/Index2?parcel=24-25-27-2325-00A00-0080>) on our address showing my wife and I purchased this home on 18 Apr 2003. I have also enclosed a copy of our latest mortgage statement.
