**ARTICLE VI -- MANAGEMENT**



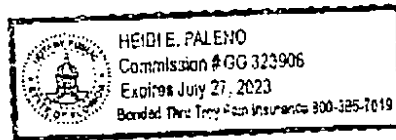
