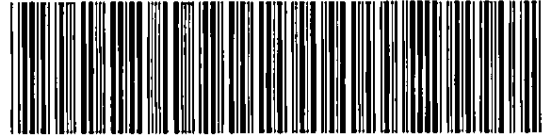

OF


