I am writing to formally address several discrepancies and unauthorized changes that have occurred concerning SCREENIN DEMON, LLC (Document Number: L21000269423), which I am the rightful owner of. Below is a detailed account of the situation:

1. Initial Filing: The original Articles of Organization for SCREENIN DEMON, LLC were filed on June 9, 2021, with the following details:

Registered Agent: INC Authority RA, 390 North Orange Ave., Ste 2300N, Orlando, FL 32801

Authorized Manager: Dwayne Lauderbaugh, 305 Stotler Ave, Inverness, FL 34452

2. Annual Report Filings:

February 9, 2022: Annual report filed reflecting changes to the principal office address to 2915 S Cygnet Terrace, Inverness, FL 34450.

Statement of Fact

April 12, 2022: An amended annual report was filed by Erica Jernigan, my ex-girlfriend, who added herself as a co-owner without my consent.

April 26, 2022: A further amendment was made to correct the original filing by adding my first name, "Joseph," which had been incorrectly listed as a middle name along with my last name.

Subsequent Filings: From February 2023 to February 2024, annual reports continued to reflect Erica's name as a co-owner without my permission.

3. Recent Developments:

On March 18, 2025, I filed an annual report to remove Erica Jernigan and listed myself as the registered agent.

On March 19, 2025, Erica Jernigan again added herself back as a co-owner without my consent.

On March 24, 2025, I filed another amendment to correct the ownership structure, affirming my sole ownership.

These actions taken by Erica Jernigan, residing at 1800 Colonnade Street, Unit 1, Inverness, FL 34453, and reachable at 3524369382, were conducted without my consent or knowledge, and I believe they constitute fraudulent behavior and retaliation against my wishes. I assert that I am the sole owner of SCREENIN DEMON, LLC.

To support my claims, I have attached copies of my driver's license, the operating agreement for SCREENIN DEMON, LLC, and records of all changes filed with the state of Florida LLC. I respectfully request that the Division of Corporations update its records to reflect the accurate ownership and ensure that no further unauthorized changes are made to the filings of SCREENIN DEMON, LLC.
