ARTICLE 1 - Name

The limited liability company is to commence its company existence effective upon filing hereof, and shall exist perpetually thereafter until dissolved according to law

ARTICLE 6 – Purpose and Powers

The limited liability company is organized for the purpose of transact any and all lawful business for which a limited liability company may be organized under the laws of the State of Florida.
