ARTICLES OF ORGANIZATION
of
CRESCENT LAKES APARTMENTS GP, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Crescent Lakes Apartments GP, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 1365 State Road 206 East, Lot R, St. Augustine, Florida 32068.

ARTICLE II

PURPOSES AND POWERS
