
ARTICLE VII NEW MEMBERS

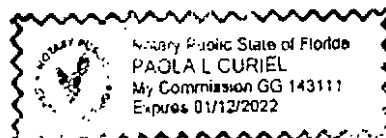
