**ARTICLES OF ORGANIZATION

ARTICLE 1

Name

The name of this limited liability company is:

Any member of the Company or its assignee shall be bound by the terms and conditions of the Company’s Operating Agreement. The Company will furnish to any member or assignee, upon request and without charge, a full statement of the restrictions and a copy of the Company’s Operating Agreement.

Indemnification

The Company shall indemnify its managers and members to the fullest extent authorized by law.
