

# ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

# ARTICLE 1 - NAME

The name of the limited liability company shall be BOUNCE BACK P. CLEANING SERVICES LLC ("Company").

### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 200 Knuth Road, Boynton Beach, Florida 33436 and the mailing address shall be the same.

# **ARTICLE 3 - EFFECTIVE DATE**

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

### **ARTICLE 4 - DURATION**

# **ARTICLE 5 - PURPOSES AND POWERS**

## ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT

These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. #### **ARTICLE 10 - INDEMNIFICATION**

If any word, clause or sentence of the foregoing provisions regarding indemnification or advancement of the attorney fees or expenses shall be held invalid as contrary to law or public policy, it shall be severable and the provisions remaining shall not be otherwise affected.
