
**STATEMENT OF FACT**  
**(of Jennifer Hopkins regarding Electronic Articles of Organization)**

I, JENNIFER L. HOPKINS, being duly sworn, state the following facts based on my personal knowledge:

1. I am submitting this "STATEMENT OF FACT" so the public, and Florida Secretary of State Divisions of Corporations, is aware that the recently electronic filed Articles of Organization for Recipe for Success Clean LLC (Document #L21000288774) is a fraudulent document.
2. My name is Jennifer Hopkins.
3. I reside at 28706 Carmel Way, Bonita Springs, Florida 34134.
4. On June 22, 2021, an Electronic Articles of Organization for Florida Limited Liability Company was filed for "Recipe for Success Clean LLC" and identified by the Florida Secretary of State as Document #L21000288774.
5. Document #L21000288774 indicates it was electronically signed by me. This is false- I never electronically signed the document.
6. Document #L21000288774 indicates that I am the registered agent of Recipe for Success Clean LLC. This is also false. Apart from being a fraudulent document, I never agreed to act as agent for Recipe for Success Clean LLC. I have also filed a related Resignation of Agent document with the Florida Secretary of State, so this point is clear.
7. Document #L21000288774 lists the street address, principal office address, mailing address, and address of registered agent for Recipe for Success Clean LLC as being 28706 Carmel Way, Bonita Springs, FL 34134. This is also false, as no business exists at this address, and certainly not Recipe for Success Clean LLC.
8. I have no knowledge of the business Recipe for Success Clean LLC.
9. I have no knowledge of the identity of the individual who operates Recipe for Success Clean LLC, nor the identity of who fraudulently submitted Document #L21000288774.
10. I will not be acting as agent, as I never agreed to do so. Someone fraudulently electronically forged my name in Document #L21000288774.

11. Again, the previously filed Articles of Organization (Document #L21000288774) contains false information, and was submitted fraudulently.


