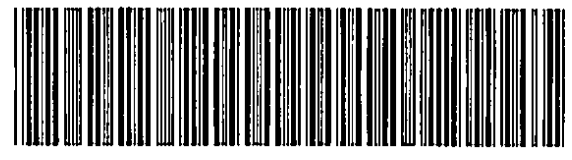



**SIXTH:** The merger shall become effective on the date the Articles of Merger are filed with the Florida Department of State.




