## AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF 109 BRUSH LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act (the "<u>Act</u>"), **109 BRUSH LLC**, a Florida limited liability company (the "<u>Company</u>"), hereby delivers these Amended and Restated Articles of Organization, duly executed by the undersigned manager of the Company (the "<u>Manager</u>"), to amend, restate and supersede the original Articles of Organization of the Company (the "<u>Original Articles</u>"). which were filed with the Florida Department of State on June 23, 2021, under the provisions of the Act, and assigned document number L21000291182.

The purpose of the Company is to (a) invest in "qualified opportunity zone property" (as defined in Section 1400Z-2 of the Code or any successor statute or section thereto), (b) engage in any and all activities permitted under applicable law relating thereto so long as such activities continue to permit the Company to qualify as a "qualified opportunity fund," and (c) engage in the trade or business of acquiring, owning, holding, operating, managing, selling, exchanging and otherwise dealing with real property, mortgage loans, and securitized interests in mortgage loans related to real property, including through one or more "qualified opportunity zone businesses" (as defined in Section 1400Z-2 of the Code or any successor statute or section thereto).
