The undersigned, Ryan Kirk, a natural person competent to contract and an authorized representative of SoWal Beach Chairs, LLC, hereby presents these Articles of Organization as the Articles of Organization of SoWal Beach Chairs, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is SoWal Beach Chairs, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”

ARTICLE VI – MANAGEMENT




