On January 25, 2021, when I first registered 711 N Myrtle Ave LLC with sunbiz.org it should have been registered as an LLC but for some reason it came through as a Corporation, even though it had "LLC" in the name. It should have been rejected by your department because LLC was listed in the name of a Corporation. However, on February 8, 2021 we received notification that 711 N Myrtle Ave LLC was approved as Florida Corporation.

On March 10, 2021, by way of email, I attempted to correct this by asking your department to have the new entity registered as an LLC. However, no reply was received.

On March 16, 2021, online with sunbiz.org I registered 711 N Myrtle Ave LLC as a Florida LLC. However, on March 28, 2021 an email was received stating the new entity could not use this name as it was already in use (by the corporation filed on January 25, 2021).

I'm requesting a refund of the original corporation filing fee of \$85.00 as your department should never have approved it as the name was formatted incorrectly. I am also requesting a refund of the \$160.00 to refile as an LLC but was declined because the new entity name was already in existence.
