ARTICLES OF ORGANIZATION OF JCM ROUNDTABLE, LLC

The undersigned, Michael Austin, a natural person competent to contract and an authorized representative of JCM Roundtable, LLC, hereby presents these Articles of Organization as the Articles of Organization of JCM Roundtable, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

<u>ARTICLE I – NAME</u>

The name of the limited liability company is JCM Roundtable, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

<u>ARTICLE III – PURPOSE AND POWERS</u>
