Articles Of Organization Of KMH CONSULTING, LLC

Article I Name

The name of the limited liability company ("Company") is KMH CONSULTING, LLC.

Article II Address

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

Article V Registered Agent and Office
