



Pursuant to the provisions of Florida Statutes §605.0202(4), the above-named Florida limited liability company hereby adopts the following Amended and Restated Articles of Organization, which amend and restate the Articles of Organization originally filed on December 12, 2019.

The undersigned for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act. Florida Statutes Chapter 605, hereby make, acknowledge, and file the following Articles of Organization pursuant to Florida Statutes §605.0201.

#### ARTICLE I NAME
