**ARTICLES OF ORGANIZATION  
OF

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I

REGISTERED AGENT AND OFFICE

ARTICLE IV

DURATION AND TERMINATION

All Managers, other than the initial Manager, shall be appointed or elected solely as provided in the Operating Agreement of the Company, if applicable, and otherwise by the Members.

OPERATING AGREEMENT


