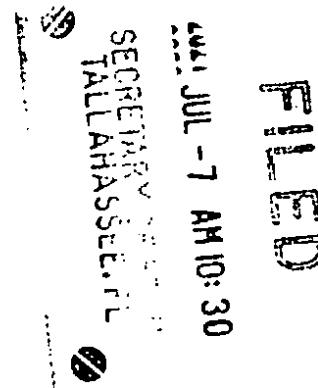
ARTICLE III — MANAGEMENT


Any subsequent manager or managers shall be appointed as provided in the Operating Agreement.


