**ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of PRRK PROPERTY, LLC, a Florida limited liability company (the "Company").

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Company is PRRK PROPERTY, LLC and its principal office and mailing address is 100 2nd Avenue South, Suite 701, St. Petersburg, FL 33701.

ARTICLE 2: DURATION

The duration of the Company is perpetual, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

ARTICLE 3: PURPOSE


ARTICLE 6: LIMITATION OF AGENCY AUTHORITY OF MEMBERS
