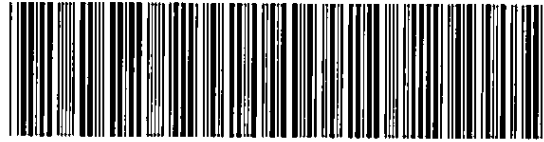

Whole Milk, LLC (the "**Company**"), a Florida limited liability company, was organized on July 8, 2021, by filing Articles of Organization ("**Articles**") with the Office of the Florida Department of State as evidenced by the assignment of instrument number L21000312867. In accordance with Section 605.0202 of the Florida Revised Limited Liability Company Act, the Company has recorded this First Amendment to Articles of Organization of the Company ("**Amendment**") to amend the Articles for the limited purpose described in this Amendment.

1. **PRESENT NAME.** The Company's name is Whole Milk, LLC.
2. **FILING DATE.** The Article's filing date was July 8, 2021.
3. **AMENDMENTS.** Articles III and V of the Articles are deleted from the Articles entirely, and the following are substituted in lieu of the original Articles III and V:

Article III

The purposes of the limited liability company are to acquire, construct, develop, finance, lease, maintain, manage, market, mortgage, operate, own, and sell the Property and to engage in any and all activities necessary or incidental to the preceding purposes.

Article V

4. **EFFECTIVE DATE.** The effective date of this Amendment is its filing date with the Office of the Florida Department of State.




