

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

# **ARTICLE 1 - NAME**

The name of the limited liability company shall be ALPHAVILLE CAPITAL LLC ("Company").

#### ARTICLE 2 - ADDRESS

### **ARTICLE 10 - INDEMNIFICATION**

All references in these Articles of Organization to "member", "manager", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
