**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I  
NAME**

The name of this limited liability company is Stage To Design, LLC, a Florida limited liability company (the "Company").

**ARTICLE II  
DURATION**


**ARTICLE IX**

The undersigned executed these Articles of Organization effective as of the 7<sup>th</sup> day of July, 2021.


