ARTICLES OF ORGANIZATION OF Luvebras, LLC

The undersigned certifies that we have associated ourselves together for the purpose of becoming a limited liability company under the Laws of the State of Florida, Chapter 605, Florida Limited Liability Company Act, providing for the information, rights, privileges, and immunities of limited liability companies for profit. ARTICLE V MEMBERSHIP RESTRICTIONS
