# ARTICLES OF ORGANIZATION OF MATRIX EMERGENCY MEDICINE, PLLC

### ARTICLE I

The name of the Company shall be: MATRIX EMERGENCY MEDICINE, PLLC

#### ARTICLE II ADDRESS AND PLACE OF BUSINESS

## ARTICLE III PERIOD OF DURATION

These Articles of Organization shall be effective on the date of their filing, and thereafter the Company shall have perpetual duration.

# ARTICLE IV PURPOSE, GENERAL POWERS, AND RENDITION OF PROFESSIONAL SERVICES

The Company is formed for the purpose of rendering professional services and conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621, Florida Statutes, and, to the extent not inconsistent with Chapter 621, Florida Statutes, any and all activities and actions authorized under Florida Revised Limited Liability Company Act, Chapter 605.

The company shall render the professional services only through its agents, officers, directors, employees, and representatives who are duly licensed or otherwise legally authorized in the State of Florida to practice osteopathic or allopathic medicine or to provide medical and healthcare services. The term "agents," "officers," "employees," and "representatives" shall not include clerks, secretaries, bookkeepers, office managers, or others who are not usually and ordinarily considered by custom and practice to be rendering professional services to the public in a manner for which a license or other legal authorization is required.

# ARTICLE V MANAGEMENT

All powers of the Company shall be exercised by or under the authority of the members and, except as otherwise provided in the Operating Agreement of the Company (as defined in Article VIII)), the business

and affairs of the Company shall be managed by or under the direction of one or more Managers and Authorized Members). The initial Manager and Authorized Member of the Company shall be <u>ANTHONY</u> J. PETERS, D.O., 5720 - 6TH AVENUE NW, BRADENTON, FLORIDA 34209, who can enter into contracts on behalf of, and bind the Company.

#### ARTICLE VI RIGHT TO CONTINUE BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of member in the Company, the business of the Company shall not cease and the Company shall not cease and the Company shall not be dissolved except by the unanimous consent of the remaining members or as otherwise provided in the Operating Agreement of the Company.

#### ARTICLE VII RESTRICTIONS ON MEMBERSHIP

New members shall be admitted to the Company in accordance with the Operating Agreement of the Company. Additional restrictions and conditions on membership may be set forth in the Company's Operating Agreement or other agreements adopted by the members.

# ARTICLE VIII OPERATING AGREEMENT

The members of the Company may adopt an Operating Agreement pertaining to the regulation, management, and other affairs of the Company (the "Operating Agreement"), provided that such Operating Agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The Operating Agreement may be repealed or altered only in the manner now or hereafter prescribed therein, consistent with the laws of the State of Florida.

# ARTICLE IX REGISTERED OFFICE AND REGISTERED AGENT

The street address of the Company's initial registered office in Florida is 5720 - 6TH AVENUE NW, BRADENTON, FLORIDA 34209, and the name of its initial registered agent is ANTHONY J. PETERS, D.O. The Company may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Section 605.0113, Florida Statutes.
