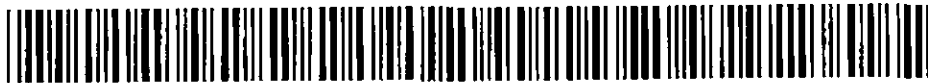

TO THE
ARTICLES OF ORGANIZATION
OF

Pursuant to *Chapter 605, Florida Statutes*, the undersigned desires to amend the Articles of Organization for Applied Utility Auditing, LLC, a Florida limited liability company, that were filed with the Florida Secretary of State under Document Number L21000322425 (collectively the "Articles of Organization") on July 14, 2021.
