ARTICLES OF ORGANIZATION OF

ALMERIA INVESTMENTS GROUP LLC

ARTICLE I NAME

The name of this Limited Liability Company shall be Almeria Investments Group LLC (the "Company").

ARTICLE II DURATION

The Company shall exist perpetually, unless sooner dissolved or extended further in a manner provided by law, or as provided in the regulations adopted by the members (the "Regulations").
