**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
LIVE EDGE SLABS OF PORTLAND, LLC**

Pursuant to Florida Statutes Section 605.0202, the Articles of Organization of LIVE EDGE SLABS OF PORTLAND, LLC, a Florida limited liability company, are hereby amended as follows:
