

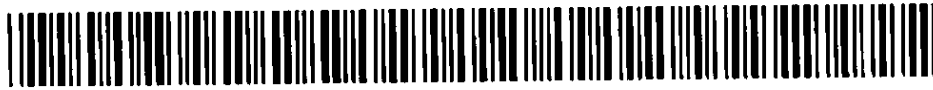


To Whom It May Concern:

ARTICLE III - Amendment


The following amendment to the Articles of Organization of the limited liability company was adopted by the limited liability company:
